

Corporate Contributor License Agreement (CLA)

between

- I Contributor, identified above as person or entity, intends to share software code, documentation or other original works of authorship with ThinkParQ (in the following “contributions”). Contributor accepts and agrees to the below license terms which are subject to all present and future contributions of the Contributor. This CLA serves the purpose of protecting all parties involved, including the customers of ThinkParQ.
- II Contributor hereby warrants that it is the sole owner of all copyrights and IP rights in and to the contributions including its alterations and amendments, that it is its original creation and that it is fully entitled to grant the rights hereunder and that no third parties rights exist in the contributions. If Contributor is an entity, Contributor warrants that it is unconditionally authorized for an unlimited duration to make this contribution and to grant the rights hereunder. For legal entities, the entity making a contribution and all other entities that control, are controlled by, or are under common control with that entity are considered to be a single Contributor. For the purposes of this definition, “**control**” means (i) the power, direct or indirect, to cause the direction or management of such entity, whether by contract or otherwise, or (ii) ownership of fifty percent (50%) or more of the outstanding shares, or (iii) beneficial ownership of such entity.
- III Contributor shall not be obliged to provide support / maintenance for the contributions but is free to provide it on a voluntary basis.
- IV With the exception of the warranties pertaining to the ownership of rights stipulated in clause II the contribution is provided on an “AS IS” basis, without warranties of any kind, either express or implied, including, but not limited, to merchantability and/or fitness for a particular purpose, unless required by applicable law or agreed to in writing.
- V Contributor hereby grants to ThinkParQ a worldwide, non-exclusive, royalty-free, irrevocable sublicensable copyright license for an unlimited duration and without restriction as to content, to use the contribution and its amendments and

alterations to the fullest extent permitted under German copyright law in any hardware and software environment, as well as to reproduce, prepare derivative works of, publicly display and perform and distribute the contribution and derivative works thereof, as well as to assert claims for damages against third parties in its own name based on unauthorized use of the contribution. The license includes ThinkParQ's right to commercially use the contribution and its amendments and alterations.

VI Contributor hereby grants to ThinkParQ a perpetual, worldwide, non-exclusive, royalty-free, irrevocable sublicensable license in and to any intellectual property rights incorporated in the contribution to use in any hardware and software environment, make, have made, offer for sale, sell, import and otherwise transfer the work, in which the contribution is incorporated, as well as to assert claims for damages against third parties in its own name based on unauthorized use of the contribution. The license applies only to those patent claims necessarily submitted by the contribution alone or by the combination of the contribution with other software. If any entity initiates patent litigation against the Contributor or any other entity (including a counterclaim in litigation) alleging that the contribution or the work to which the contribution constitutes direct or contributory patent infringement, then all patent licenses granted to that entity under this Agreement for that contribution or work will terminate as of the date the litigation is filed. The license includes ThinkParQ's right to commercially use the contribution and its amendments and alterations.

VII The use under this agreement includes to store and load the contribution permanently or temporarily, to display and run it, to modify, translate, edit or transform it in any other way for commercial and non-commercial purposes on any known medium or in any other way, to store, reproduce, exhibit, publish, distribute in physical or non-physical form, in particular to reproduce, including by means of image, sound and other information carriers, to use the contribution in databases, data networks and online services, including the right to make the contribution available to users of the aforementioned databases, networks and online services.

VIII This agreement shall be governed by the laws of Germany with the exception of the German rules on Private International Law (IPR)
